Equal Opportunity Policy for Persons with Disabilities employees in respect of employees of Agriculture Department, Himachal Pradesh

Background:

The Government of India has enacted Rights of Persons with Benchmark Disabilities (RPwD) Act, 2016. The Section 21(1) state that every establishment shall notify Equal Opportunity Policy and also Section 21(2) of the Act, envisages that every establishment shall register a copy of the said policy with the State Commissioner for the Persons with Disability.

Objective:

The Policy aims to safeguard the equality of self determination, dignity and inclusion of Persons with Benchmark Disabilities employees working in the Directorate as well as at Districts and Tehsil level offices.

The objectives of this policy is to ensure that all the Persons with Benchmark Disability Employees of this Department are not only to improve the quality of life of persons with benchmark disability, but also to promote and safeguard equality, self-determination, dignity and social inclusion of persons with benchmark disability.

The Persons with Benchmark Disabilities include those who have long-term physical, mental, intellectual or sensory impairments should have to process certificate of disability issued by a competent authority under Section 57 of the RPwD Act, 2016.

Applicability:

This Policy is applicable to the Employees having Benchmark Disability of the Department. This Policy is consonantly applied throughout the period of employment of the employee right from his/her recruitment till retirement in the Department.

Policy:

It is the policy of Department of Agriculture, Himachal Pradesh, to provide equal employment opportunities, without any discrimination on the grounds of caste, colour, disability, marital status, nationality, race, religion, sexual orientation. The Agriculture Department, retrieve to maintain a work environment that is free from any harassment based on above considerations.

This Equal Opportunity Policy is subject to applicable regulations, qualifications and merit of the individual. This Policy will consistently be applied throughout the period of employment of the individual, right from the recruitment process till retirement from service.

Equal Opportunity and Non-Discrimination:

In accordance with the provision of the Rights of Persons with Disabilities Act, 2016 and Rules, 2017 made thereunder, it is the policy of Agriculture Department to ensure that the work environment is free from any discrimination against the Persons with Benchmark Disabilities. Further, the Agriculture Department will take all actions to ensure the conducive environment is provided to persons with benchmark disabilities to perform their role and excel in the same. The Agriculture Department strives towards establishing systems and processes to ensure:—

1. That appropriate facilities and amenities would also be provided to persons with disabilities to enable them to effectively discharge their duties in the establishment and no officer/official shall be deprived of his or her personal liberty on the ground of disability.
2. That provision shall be made for an accessible environment, accessible buildings and availability of assistive paraphernalia as required to enable the persons with benchmark disabilities to effectively discharge their duties in the establishment.
3. That the various sections in the Directorate and in the respective Offices at Districts will ensure that if any grievance does arise & is brought up to the notice of concerned committee/officer with respect to selection of Persons(s) with Benchmark Disabilities for any position, training, promotion, transfer, posting, leave, assistive aid & preference in accommodation allocation etc. is dealt within a fair and equitable manner free from any discrimination.
4. That no opportunities are denied to persons with disabilities merely on the ground of his disability.
5. No discrimination practices are to be engaged in the course of employment of persons with a benchmark disability, including recruitment and career advancement or not to dispense with or reduce in rank an employee who acquires a disability during his or her service. Provided that if any employee after acquiring disability is not suitable for the post he was holding, shall be shifted to some other post with the same pay scale and service benefits. Provided further that if it is not possible to adjust the employee against any post, he/she may be kept on a supernumerary post until a suitable post is available or he/she attains the age of superannuation, whichever is earlier.

Identification of posts for reservation:

The Department of Agriculture shall identify the posts reserved for Persons with Benchmark Disabilities as per section 34(1) of the RPwD Act, 2016 that provides 4% reservation to the Persons with Benchmark Disabilities. The identified posts shall be filled up by the Agriculture Department as per the directions issued by the State Govt. from time to time and the same shall also be furnished to the employment exchange.

Manner of Selection:

The Agriculture Department adopts the selection policy of the State Government regarding filling up of posts reserved for Persons with Disabilities.

Leave:

The Specially Abled Employees of this Department will be governed by the rules of leave specified by the State Govt. from time to time.

Liaison Officer:

Appointment of liaison officer will be made by the department to look after the recruitment of persons with disabilities and provisions of facilities and amenities for such employees.

Complaints/Grievance and their Disposal:

The Grievance Redressal Officer shall maintain a register of complaints/grievances and to hear the pleading/request of Persons with Disabilities working in the Agriculture Department.

Responsibility:

- Department of Agriculture is responsible for utilization of up to date information regarding applicable laws and rules for Persons with Disabilities.
- Deputy Director of Agriculture should be responsible for giving effect to this policy at District Level.
- Any employee who violates this policy shall be dealt in accordance with applicable rules and laws.

Communication of Policy:

This policy will be available to all employees via this Department website (hpagriculture.com) as well as will publish in the Rajpatra also.

Maintenance of Record:

Records shall be maintained as per the provisions of laws and the rules there under, shall maintain in relation to the matter of employment, facility provided and other necessary information in compliance with the provisions of laws.

C. Wholesaler: 500 quintals
Retailer: 20 quintals

An exporter, being a refiner, miller, extractor, wholesaler or retailer or dealer, having Importer-Exporter Code Number issued by the Director General of Foreign Trade, if such exporter is able to demonstrate that the whole or part of his stock in respect of edible oils and edible oilseeds are meant for exports, to the extent of the stock meant for export.

An importer, being a refiner, miller, extractor, wholesaler or retailer or dealer, if such importer is able to demonstrate that part of his stock in respect of edible oils and edible oilseeds are sourced from imports.

In case, the stocks held by respective legal entities are higher than the prescribed limits then they shall declare the same on the portal (<https://evegoils.nic.in>) of Department of Food & Public Distribution and bring it to the prescribed stock limits as decided by the State/UT administration where it is conducting its business within 30 days of the issue of such notification by the said authorities.

It shall be ensured that Edible Oils and Edible Oilseeds stock is regularly declared and updated on the portal of this Department i.e. Department of Food & Public Distribution (<https://evegoils.nic.in>).

(ए.पी.)—सी—ए (3)—3/2007—I.—हिमाचल प्रदेश के राज्यपाल, भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हिमाचल प्रदेश लोक सेवा आयोग के परामर्श से, इस विभाग की अधिसूचना संख्या पी.ई.आर. (ए.पी.)—सी—ए (3)—7/2010, तारीख 03 अगस्त, 2011 द्वारा अधिसूचित हिमाचल प्रदेश कार्मिक विभाग, वरिष्ठ सहायक, वर्ग—III (अराजपत्रित, लिपिक वर्गीय सेवाएं) सामान्य भर्ती और प्रोन्नति नियम, 2011 का और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:—

1. संक्षिप्त नाम और प्रारम्भ.—(1) इन नियमों का संक्षिप्त नाम हिमाचल प्रदेश कार्मिक विभाग, वरिष्ठ सहायक, वर्ग—III (अराजपत्रित, लिपिक वर्गीय सेवाएं) सामान्य भर्ती और प्रोन्नति (छठा संशोधन) नियम, 2021 है।

(2) ये नियम राजपत्र (ई—गजट), हिमाचल प्रदेश में प्रकाशित किए जाने की तारीख से प्रवृत्त होंगे।

(3) ये नियम हिमाचल प्रदेश विधान सभा सचिवालय, हिमाचल प्रदेश उच्च न्यायालय और हिमाचल प्रदेश सचिवालय को अपवर्णित करके हिमाचल प्रदेश राज्य के समस्त सरकारी विभागों को लागू होंगे।

2. उपाबंध—‘क’ का संशोधन.—हिमाचल प्रदेश कार्मिक विभाग, वरिष्ठ सहायक, वर्ग—III (अराजपत्रित, लिपिक वर्गीय सेवाएं) सामान्य भर्ती और प्रोन्नति नियम, 2011 के उपाबंध—‘क’ में,—

(क) स्तम्भ संख्या: 11 के सामने विद्यमान उपबन्धों के स्थान पर निम्नलिखित रखा जाएगा, अर्थात्:—

“सम्बद्ध विभागों के लिपिक (लिपिकों)/कनिष्ठ कार्यालय सहायक (सहायकों) (आई0टी0)/कनिष्ठ सहायक (सहायकों) या रेस्टोरर [केवल ऐसे स्थापन (स्थापनों) जहां, वरिष्ठ सहायक के पद के सामान्य भर्ती एवं प्रोन्नति नियमों की अधिसूचना से पूर्व विद्यमान भर्ती एवं प्रोन्नति नियमों में वरिष्ठ सहायक के पद प्रोन्नति के लिए रेस्टोरर पोषक प्रवर्ग था] में से प्रोन्नति द्वारा, जो 10+2 या इसके समतुल्य जैसे हायर सेकेण्डरी पार्ट-II, इन्टरमिडिएट आदि की अपेक्षित शैक्षिक अर्हता धारण करने के अध्यक्षीन, जिनका लिपिक/कनिष्ठ सहायक या कनिष्ठ कार्यालय सहायक (आई0टी0)/कनिष्ठ सहायक के रूप में संयुक्त: सात वर्ष का नियमित सेवाकाल या ग्रेड में की गई लगातार तदर्थ सेवा, यदि कोई हो, को सम्मिलित करके सात वर्ष का नियमित सेवाकाल हो।”

प्रोन्नति के प्रयोजन के लिए लिपिक/कनिष्ठ सहायक या कनिष्ठ कार्यालय सहायक (आई0टी0)/कनिष्ठ सहायक और रेस्टोरर के पात्र पदधारियों की उनकी नियमित नियुक्ति की तारीख से पोषक प्रवर्ग में उनकी पारस्परिक वरिष्ठता को छोड़े बिना एक संयुक्त वरिष्ठता सूची तैयार की जाएगी। नियमित नियुक्ति की एक ही तारीख होने की दशा में पदधारियों को लिपिकों और कनिष्ठ सहायकों (आई0टी0) में ऐसे चक्रानुक्रम अर्थात् एक-एक के अनुपात में विचार में लिया जाएगा:

परन्तु रेस्टोरर प्रवर्ग के उन पदधारियों, जिन्होंने लिपिकों के लिए यथा विहित परीक्षा टंकण अर्हित की है, को ही वरिष्ठ सहायक के पद की प्रोन्नति के लिए विचार में लिया जाएगा:

(I) परन्तु प्रोन्नति के प्रयोजन के लिए प्रत्येक कर्मचारी को, जनजातीय/कठिन/दुर्गम/और दूरस्थ/ग्रामीण क्षेत्रों में पद(पदों) की ऐसे क्षेत्रों में पर्याप्त संख्या की उपलब्धता के अध्यक्षीन, कम से कम एक कार्यकाल तक सेवा करनी होगी:

परन्तु यह और कि उपरोक्त परन्तुक (I) दूरस्थ/ग्रामीण क्षेत्रों में तैनाती/स्थानान्तरण के सिवाय उन कर्मचारियों के मामले में लागू नहीं होगा, जिनकी अधिवर्षिता के लिए पांच वर्ष की या उससे कम की सेवा शेष रही हो। तथापि पांच वर्ष की यह शर्त प्रोन्नति के मामलों में लागू नहीं होगी:

परन्तु यह और भी कि उन अधिकारियों/कर्मचारियों को जिन्होंने जनजातीय/कठिन/दुर्गम क्षेत्रों/और दूरस्थ/ग्रामीण क्षेत्रों में कम से कम एक कार्यकाल तक सेवा नहीं की है, ऐसे क्षेत्र में उसके अपने संवर्ग (काडर) में सर्वथा उसकी वरिष्ठता के अनुसार स्थानान्तरण किया जाएगा।

स्पष्टीकरण I:—उपर्युक्त परन्तुक (I) के प्रयोजन के लिए जनजातीय/कठिन/दुर्गम क्षेत्रों/और दूरस्थ/ग्रामीण क्षेत्रों में “कार्यकाल” से प्रशासनिक अत्यावश्यकताओं/सुविधा को ध्यान में रखते हुए साधारणतया तीन वर्ष की अवधि या ऐसे क्षेत्रों में तैनाती की इससे कम अवधि अभिप्रेत होगी।

स्पष्टीकरण II:—उपरोक्त परन्तुक (I) के प्रयोजन के लिए जनजातीय/कठिन क्षेत्र निम्न प्रकार से होंगे:—

1. जिला लाहौल एवं स्पिति
2. चम्बा जिला का पांगी और भरमौर उप-मण्डल
3. रोहडू उप मण्डल का डोडरा क्वार क्षेत्र
4. जिला शिमला की रामपुर तहसील का पन्द्रह बीस परगना, मुनिश, दरकाली और ग्राम पंचायत काशापाट।
5. जिला कुल्लू का पन्द्रह बीस परगना

6. कांगड़ा जिला के बैजनाथ उप-मण्डल का बड़ा भंगाल क्षेत्र
7. जिला किन्नौर
8. सिरमौर जिला में, उप तहसील कमरु के काठवाड़ और कोरगा पटवार वृत्त, रेणुकाजी तहसील के भलाड़-भलौना और सांगना पटवार वृत्त और शिलाई तहसील का कोटा पाब पटवार वृत्त।

No. Per (AP)-C-A (3)-3/2007-I.—In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor of Himachal Pradesh, in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the following rules further to amend the Himachal Pradesh, Department of Personnel, Senior Assistant, Class-III (Non-Gazetted, Ministerial Services), Common Recruitment and Promotion Rules, 2011 notified *vide* this Department Notification No. Per(AP)-C-A(3)-7/2010 dated 3rd August, 2011, namely:—

1. Short title and commencement.—(1) These rules may be called the Himachal Pradesh, Department of Personnel, Senior Assistant, Class-III (Non-Gazetted, Ministerial Services) Common Recruitment and Promotion (Sixth amendment) Rules, 2021.

(2) These rules shall come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.

(3) These rules shall be applicable to all the Government Departments of State of Himachal Pradesh excluding the posts of the Vidhan Sabha Secretariat/High Court of Himachal Pradesh and Himachal Pradesh Secretariat.

2. Amendment of Annexure-A.—In Annexure-A of the Himachal Pradesh, Department of Personnel, Senior Assistant, Class-III (Non-Gazetted, Ministerial Services) Common Recruitment and Promotion Rules, 2011.

- (a) For the existing provisions against Col. No. 11, the following shall be substituted, namely:

“By promotion from amongst the Clerk(s)/Junior Office Assistant(s) (IT)/Junior Assistant(s) of the concerned Departments or Restorer [only in such establishment(s) where the category of Restorer was a feeder category for promotion to the post of Senior Assistant in the prevailing R&P Rules prior to notification of Common R&P Rules for the post of Senior Assistant] subject to possessing of requisite educational qualification of 10+2 or its equivalent like Higher Secondary Part-II, Intermediate etc., with seven years regular service or regular combined with continuous *ad hoc* service rendered, if any, as Clerk/Junior Assistant or Junior Office Assistant (IT)/Junior Assistant combined.

For the purpose of promotion a combined seniority list of eligible incumbents of the posts of Clerk/Junior Assistant/Junior Office Assistant (IT)/Junior Assistant and Restorer shall be drawn according to their regular dates of appointments in the feeder category posts without disturbing their *inter-se* seniority. In the case of same date of regular appointments, the incumbent will be considered by rotation *i.e.* on one to one basis so placed from Clerks and Junior Office Assistants (IT):

Provided that only those incumbents of Restorer category who have qualified typing test as prescribed for Clerks will be considered for promotion to the post of Senior Assistant:

(I) Provided that for the purpose of promotion every employee shall have to serve atleast one term in the Tribal/Difficult/Hard areas and remote/rural areas subject to adequate number of post(s) available in such areas:

Provided further that the proviso (I) *supra* shall not be applicable in the case of those employees who have five years or less service, left for superannuation except posting/transfer in remote/rural area. However, this condition of five years shall not be applicable in cases of promotion:

Provided further that Officer/Official who has not served atleast one tenure in Tribal/Difficult/Hard areas and remote/rural areas shall be transferred to such area strictly in accordance with his/her seniority in the respective cadre.

Explanation I:—For the purpose of proviso (I) *supra* the “term” in Tribal/Difficult/Hard area/remote/rural areas shall mean normally three years or less period of posting in such areas keeping in view the administrative exigencies/convenience.

Explanation II:—For the purpose of proviso (I) *supra* the Tribal/Difficult Areas shall be as under:—

1. District Lahaul & Spiti
2. Pangi and Bharmour Sub Division of Chamba District
3. Dodra Kwar Area of Rohru Sub-Division
4. Pandrah Bis Pargana, Munish Darkali and Gram panchayat Kashapat of Rampur Tehsil of District Shimla.
5. Pandrah Bis Pargana of Kullu District

6. Bara Bhungal Areas of Baijnath Sub Division of Kangra District
7. District Kinnaur
8. Kathwar and Korga Patwar Circles of Kamrau Sub Tehsil, Bhaladh Bhalona and Sangna Patwar Circles of Renukaji Tehsil and Kota Pab Patwar Circle of Shillai Tehsil, in Sirmaur District.
9. Khanyol-Bagra Patwar Circle of Karsog Tehsil, Gada-Gussaini, Mathyani, Ghanyar, Thachi, Baggi, Somgad and Kholanal of Bali-Chowki Sub Tehsil, Jharwar, Kutgarh, Graman, Devgarh, Trailla, Ropa, Kathog, Silh-Badhwani, Hastpur, Ghamrehar and Bhatehar Patwar Circle of Padhar Tehsil, Chiuni, Kalipar, Mangarh, Thach-Bagra, North Magru and South Magru Patwar Circles of Thunag Tehsil and Batwara Patwar Circle of Sunder Nagar Tehsil in Mandi District.

Explanation III:—For the purpose of proviso (I) *supra* the Remote/ Rural Areas shall be as under:

- (i) All stations beyond the radius of 20 Kms. from Sub Division/Tehsil headquarter
- (ii) All stations beyond the radius of 15 Kms. from State Headquarter and District headquarters where bus service is not available and on foot journey is more than 3 (three) Kms.
- (iii) Home town or area adjoining to area of home town within the radius of 20 Kms. of the employee regardless of its category.

(II) In all cases of promotion, the continuous *adhoc* service rendered in the feeder post if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these rules for promotion subject to the conditions that the *adhoc* appointment/promotion in the feeder category had been made after following proper acceptable process of selection in accordance with the provisions of R & P Rules:

(i) Provided that in all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including the service rendered on *adhoc* basis followed by regular service/appointment) in the feeder post in view of the provisions referred to above, all persons senior to him in the respective category/post/ cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration:

Provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of at least three years' or that prescribed in the Recruitment & Promotion Rules for the post, whichever is less:

Provided further that where a person becomes ineligible to be considered for promotion on account of the requirements of the preceding proviso, the person(s) junior to him shall also be deemed to be ineligible for consideration for such promotion.

Explanation:—The last proviso shall not render the junior incumbents ineligible for consideration for promotion if the senior ineligible persons happened to be Ex-servicemen who have joined Armed Forces during the period of emergency recruited under the provisions of rule-3 of Demobilized Armed Forces Personnel (Reservation of Vacancies in Himachal State Non-Technical Services) Rules, 1972 and having been given the benefit of seniority thereunder or

recruited under the provisions of rule-3 of Ex-Servicemen (Reservation of Vacancies in the Himachal Pradesh Technical Service) Rules, 1985 and having been given the benefit of seniority thereunder.

(ii) Similarly, in all cases of confirmation, continuous *adhoc* service rendered on the feeder post if any, prior to the regular appointment against such posts shall be taken into account towards the length of service, if the *adhoc* appointment/promotion had been made after proper selection and in accordance with the provisions of the Recruitment & Promotion Rules:

Provided that *inter-se-seniority* as a result of confirmation after taking into account, *adhoc* service rendered shall remain unchanged.”
